

Odense Robotics membership conditions

Membership fees and payment

The membership fee for the association Odense Robotics is determined by the association's CEO/executive leadership team following approval by the board of directors. An Odense Robotics membership spans the period 1 January – 31 December. Members receive an invoice in December, with payment due between 1 January and 20 January at the latest. Memberships starting in the middle of the calendar year automatically continue from 1 January. Membership is a continuous subscription. Members who join during the 1st or 2nd quarter will be invoiced for the full annual membership fee, while members who join during the 3rd or 4th quarter will be invoiced for half of the annual membership fee. Members will be billed immediately after registration.

Member categories

When you apply to become a member of the association Odense Robotics, you must select one of the following categories:

- DK: General – free
- DK: Startup (less than three years after CVR nr. registration date)
- DK: Company 1-9 employees
- DK: Company 10-49 employees
- DK: Company 50-249 employees
- DK: Company 250-999 employees
- DK: Company 1,000 employees or more
- DK: Research, knowledge and/or educational institution
- Outside DK: Company / institution / organisation

Danish companies select the member category corresponding to the number of employees in Denmark as stated in the relevant CVR number. In November each year, the association Odense Robotics determines the membership category for the following year based on the number of employees in Denmark as shown in the CVR register. If this figure is not provided, Odense Robotics will find this information by looking in other public databases or contacting the company.

Change of membership category

Members can change categories during the calendar year by sending an email to: info@odenserobotics.dk.

You can change from a non-paying membership ("General") to paying member (e.g. "Company 10-49 employees"). Invoicing is conducted according to the payment conditions described under "Membership fees and payment".

You can change from paying membership (e.g. "Company 10-49 employees") to non-paying membership ("General"). This requires six months' notice in writing prior to the end of the membership year (1 January-31 December). This means that requests to change to this membership category must be made before 1 July in the same year. In the event of overdue membership fee, this must be paid and paid membership fees will not be refunded. As a result, your membership benefits will continue until the membership fee year ends on 31 December.

Termination of membership

Termination of membership of the association Odense Robotics requires six month's written notice by the end of the Odense Robotics membership fee year (1 January-31 December). This means that termination must occur by 1 July of the current year. This is in accordance with the regulations for the association Odense Robotics.

Membership is considered terminated with immediate effect if a member ceases to conduct business eligible for membership or if a notice of bankruptcy is passed. Paid membership fees are not refunded.

Betaling af medlemskab

Prisen for medlemskab af foreningen Odense Robotics fastsættes af foreningens direktør/direktion efter godkendelse fra bestyrelsen. Et medlemskab af Odense Robotics strækker sig over perioden 1. januar - 31. december. Medlemmer modtager en faktura i december måned til forfald 1. januar og betaling senest 20. januar. Et medlemskab indgået midt i et kalenderår fortsætter automatisk i det kommende år. Medlemskabet er et løbende abonnement. Medlemmer, der indmeldes i 1. eller 2. kvartal, betaler det fulde årlige kontingent, mens medlemmer, der indmeldes i 3. eller 4. kvartal, betaler halvdelen af det årlige kontingent. Fakturering sker i umiddelbar forlængelse af indmeldelse.

Du kan skifte fra at være betalende medlem (fx "Virksomhed 10-49 ansatte") til at være ikke betalende medlem ("Interessentmedlemskab"). Dette skal ske med seks måneders skriftligt varsel til udløbet af Odense Robotics kontingentår (1/1-31/12). Dette betyder, at anmodning om skift til denne medlemskategori skal ske inden 1. juli i det indeværende år. Eventuelt forfaldent kontingent skal betales og der refunderes ikke indbetalt kontingent, hvorfor dine fordele som betalende medlem fortsætter indtil kontingentårets udløb 31.12.

Udmeldelse

Udmeldelse af foreningen Odense Robotics skal ifølge vedtægterne ske med mindst seks måneders skriftligt varsel til udløbet af Odense Robotics kontingentår (1/1-31/12). Dette betyder, at udmeldelse skal ske inden 1. juli i det indeværende år. Medlemskabet anses dog for ophørt med øjeblikkelig virkning, hvis et medlem ophører med at drive medlemsberettiget virksomhed eller ved afsigelse af konkursdekret.
